In pursuance of the Orders and Notifications issued from time to time by different authorities including this Corporation, compiled instructions are issued as hereunder for compliance by all concerned in this Corporation.

1. Fine for Passenger and crew:

- (a) Under Section 200 of Motor Vehicles Act, 1988 authorized officer will take steps to compound offences committed by any passenger for ticketless travelling under Sub-section (1) of Section 178 and realize spot penalty of Rs. 150/- for City routes. An offence committed by any conductor or driver under Sub-section (2) of Section 178 will pay Rs. 500/-, if a higher penalty or any other punishment is not awarded to the erring driver/conductor.

2. Students' Concession:

- (a) A student is allowed to travel by CSTC buses of 'General' and 'Special' categories with a concession @ 25% of the usual bus fare. Executive and AC buses will have no such facility.

3. Bus Pass:

- (a) CSTC will allow to travel free of cost such person, on production of valid handicapped certificate, issued by the Social Welfare Department, Govt. of West Bengal, who are fully blind / mentally retarded and incapable to move. Such person will also be allowed with another accompanying her or him.
- (b) Life challenged persons will be allowed to travel free of cost on production of Medical Certificate of ART Centre.
- (c) Employees of CSTC and employees of Govt. Pool Car Office will be allowed to travel free of cost on production of valid Identity Card issued by concerned authority.
- (d) Police personnel and other specially recommended persons will be allowed to travel free of cost on production of valid Identity Card/ Pass issued by respective authority.

For the purpose of travelling without tendering fare as mentioned under (a) to (d) above AC and Executive buses will not come under the purview.

4. Monthly Card:

A regular commuter of fixed point-to-point journey may purchase monthly pass from CSTC, subject to its availability by tendering actual fare of 18 days between such points of a particular category of bus. A person holding such valid Monthly Card will be allowed to travel between the stated points on all working days of the month. A commuter holding valid Monthly Card of AC service will be entitled to travel by any category of buses. Similarly one having Monthly Card for Executive Route will be allowed to travel by other categories of buses except AC buses.
